- Vendors may arrive on Thursday or Friday, October 8 or 9. Set up time starts at 9am. Vehicles (other than those displayed) must be cleared from the grounds by 4:30 pm on Thurs & Fri, 9:30 am on Saturday and 10:30 am on Sunday. Vendors must be available for the entire Festival through Sunday, October 11.
